Member Board Profile Terminology

The following terms are used throughout all profiles:

Board of Nursing: Jurisdiction's governmental agency responsible for the regulation of nursing practice. Includes any other terminology to refer to the regulatory authority (i.e. commission, examiners, registration, jurisdiction). When referring to board of nursing, the reference collectively includes Board Members, Executive Officer and Staff.

Jurisdiction: Refers to state, territory or district where a board of nursing is located. May also be used to refer generally to the board of nursing in a particular jurisdiction.

Board Staff: Staff of the board of nursing


Executive Officer: Person responsible for running the board of nursing. Includes any other terminology to refer to that authorized person (i.e. Executive Director)

Board Member: Member of the governing body of the board of nursing as outlined by statute

Practical nurse or PN: licensed practical or vocational nurse (LPN/LVN)



Q1. What is the total number of mandated board members?



Q2. How many RNs are mandated for inclusion as board members?



Q3. How many PNs are mandated for inclusion as board members?



Q4. How many advanced practice nurses are mandated for inclusion as board members?



Q5. Are specific advanced practice roles mandated for inclusion as board members?





Q7. How many public/consumer members are mandated for inclusion as board members?



Q8. How many physician members are mandated for inclusion as board members?







Q12. Are nurse board members required to be currently employed in nursing at time of appointment/election?



Q13. Are nurse board members required to be licensed within the jurisdiction at time of appointment/election?







Q16. Are consumer board members excluded from participation in selected functions/duties of the Board of Nursing?



Q17. Are board members appointed or elected?



Q18. How are board members appointed?



Q19. What is the length of a single term for board members?




Q20. How many consecutive terms may board members serve?





Q25. How many regular board member meetings were held in the last fiscal year?



Q26. Can non-board members be appointed to serve on board member committees, task forces, etc.?



Q27. Are committees comprised of board members and/or board staff utilized to complete assigned tasks for the Board of Nursing?



Q28. Were the nursing laws amended this year?





Q32. Do statutes known as sunrise laws exist for the Board of Nursing?



Q33. Does the Board of Nursing draft or approve its budget?



Q34. Is the Board of Nursing budget cycle based on a fiscal year beginning January 1 or a fiscal year beginning on a date other than January 1?



Q35. Can supplemental budget requests be submitted?



Q36. What percent of the budget is allocated for disciplinary matters?



Q37. What percent of the budget is allocated for licensure (initial and renewals)?



Q38. What percent of the budget is allocated for education program approval?





Q40. Does the Board of Nursing have a fund balance?



Q41. Is the Board of Nursing financially self-sustaining (able to fund/sustain self through self-generate funds only)?




