Member Board Profile Terminology

The following terms are used throughout all profiles:

Board of Nursing: Jurisdiction's governmental agency responsible for the regulation of nursing practice. Includes any other terminology to refer to the regulatory authority (i.e. commission, examiners, registration, jurisdiction). When referring to board of nursing, the reference collectively includes Board Members, Executive Officer and Staff.

Jurisdiction: Refers to state, territory or district where a board of nursing is located. May also be used to refer generally to the board of nursing in a particular jurisdiction.

Board Staff: Staff of the board of nursing

Executive Officer: Person responsible for running the board of nursing. Includes any other terminology to refer to that authorized person (i.e. Executive Director)

Board Member: Member of the governing body of the board of nursing as outlined by statute

Practical nurse or PN: Licensed practical or vocational nurse (LPN/LVN)

Program Approval: The official recognition of nursing education programs which meet standards of approval established by Boards of Nursing. Some boards of nursing use the term accreditation instead of approval, but for the purposes of this document the term used will be approval.


Articulation: seamless Matriculation from the PN degree to the ADN or BSN degree or seamless matriculation from the ADN or diploma degree to the BSN degree.

Distance Education: Instruction offered by any means where the student and faculty are in separate physical locations.







Q3. Is the Board of Nursing responsible for the approval of nursing educational programs?





Q4. Which of the following educational programs does the Board of Nursing approve? (Check all that apply)



Q5. How many exclusively online RN to BSN programs are in the jurisdiction?





Q7. Is a regular review of education programs required for ongoing program approval?







Q10. How often are <u>regular</u> site visits performed for a nursing educational program which is not nationally nursing accredited? (Check all that apply)






Q11. Are fees charged during the educational program approval process? (Check all that apply)

Q12. What is the charge for the initial approval application?



Q13. What is the charge for the continuing/renewal approval application?



Q14. What is the charge for the site visit?





Q15. Does the Board of Nursing use a specific first-time NCLEX pass rate for continuing program approval?



Q16. What standard does the Board of Nursing require for NCLEX pass rate?



Q17. What percentage of the national pass rate percentage do you require?



Q18. What percent of the first-time NCLEX pass rate do you require?





Q19. What are the minimum educational qualifications for PN program administrator?





Q20. What are the minimum educational qualifications for PN program faculty?





Q21. What is the mandated percentage of full-time faculty for PN education programs?







Q44. Does the Board of Nursing require articulation (seemless matriculation) between the following levels? (Check all that apply).



Q45. Does the Board of Nursing approve out-of-jurisdiction distance education nursing programs?




