Survey Terminology

The following terms are used throughout all surveys:

Board of Nursing: Jurisdiction's governmental agency responsible for the regulation of nursing practice. Includes any other terminology to refer to the regulatory authority (i.e. commission, examiners, registration, jurisdiction). When referring to board of nursing, the reference collectively includes Board Members, Executive Officer and Staff

Jurisdiction: Refers to state, territory or district where a board of nursing is located. May also be used to refer generally to the board of nursing in a particular jurisdiction

Board Staff: Staff of the board of nursing

Executive Officer: Person responsible for running the board of nursing. Includes any other terminology to refer to that authorized person (i.e. Executive Director

Board Member: Member of the governing body of the board of nursing as outlined by statute

Practical Nurse or PN: Licensed practical or vocational nurse (LPN/LVN)


Role: Describes the function

Title: Describes the label given to the role

Approval: The official recognition of nursing education programs which meet standards of approval established by boards of nursing. Some boards of nursing use the term accreditation instead of approval, but for the purposes of this document the term used will be approval








Q8. For any of the advanced practice roles that the jurisdiction does recognize, do the nursing statutes and/or regulations describe the scope of practice for those roles?





Q13. What is the nurse midwife's level of prescriptive authority?





Q14. What is the clinical nurse specialist's level of prescriptive authority?








Q17. What is the nurse midwife's level of controlled substance prescriptive authority? (Check all that apply)






Q19. What is the nurse practitioner's level of controlled substance prescriptive authority? (Check all that apply)




