Airport

Cleveland Hopkins International Airport (CLE)

For more information about air service to Cleveland, arrival times and terminal information, please visit the following website before embarking on your trip. The hotel is about 20 minutes from the airport.

Public Transportation

The Greater Cleveland Regional Transit Authority (RTA) is available from CLE to the hotel for \$2.75 each ride. RTA's station at CLE is located on the lower level of the main terminal. To reach the RTA station, travelers should use the elevators or escalators located in the center of the ticketing and baggage claim levels.

Taxi

Taxicabs are available on a first come, first served basis from the lower level curbside of all terminals. There are no flat rates because all taxicabs run on meters. Expect to spend approximately \$40-60 one-way.

Rideshare

Uber and Lyft pick up and drop off at CLE. The cost is approximately \$24 one-way.

Attire
