- Coordinate and facilitate stakeholder groups, as needed.
- Responsible for researching, analyzing, and developing reports pertinent to rule and policy development related to all levels of nursing education.
- Evaluate administrative rules and draft revisions or new rules based on statute or changes in legislation.
- Consult with licensing staff for complex issues regarding pre-licensure nursing education credentials and advanced practice licensure.
- Provide guidance to and survey nursing re-entry programs.
- Consult with RN and APRN re-entry nurses on education options.
