Introduction

This annual report covers the period from Oct. 1, 2023 to Sept. 30, 2024. The purpose of this report is to provide a comprehensive overview of the activities, achievements and financial performance of the Interstate Commission of Nurse Licensure Compact Administrators (ICNLCA) throughout the report period. It provides a summary of recent accomplishments and a preview of what we will achieve as a commission in fiscal year 2025 (FY25).

About the ICNLCA

The ICNLCA facilitates cross-border nursing practice through the implementation of the nationally recognized multistate license via the Nurse Licensure Compact (NLC). The ICNLCA enhances nurse mobility and public protection through maintaining uniform licensure standards among party state boards of nursing (BONs), promoting cooperation and collaboration between party states, facilitating the exchange of data and information between party states and educating stakeholders. The ICNLCA is a governmental joint public agency of the party states created and established on July 20, 2017. The Executive Committee is the seven-member elected leadership of the ICNLCA.

About the NLC

The NLC enables registered nurses (RNs) and licensed practical/vocational nurses (LPN/VNs) to hold one multistate license, with the authority to practice in person or via telehealth in both their home state and other NLC states. In FY24, 42 jurisdictions were members of the NLC. Licensing requirements are aligned in NLC states, so all nurses applying for a multistate license are required to meet the same standards, which include federal and state criminal background checks that will be conducted for all applicants for multistate licensure.

The NLC also authorizes nurses to provide telehealth services to patients located in other NLC states without obtaining additional licenses. In the event of a disaster, nurses from multiple states can easily respond to supply vital services. Additionally, many nurses, including primary care nurses, case managers, transport nurses, school and hospice nurses, among many others, need to routinely cross state boundaries to provide the public with access to nursing services, and a multistate license facilitates this process.



ICNLCA Core Purpose

To facilitate interstate nursing practice in a manner consistent with public health and safety.



ICNLCA Mission Statement

To facilitate cross-border nursing practice through the implementation of a nationally recognized multistate licensure. ICNLCA enhances nurse mobility and public protection by enforcing compliance with the Compact.

Letter from the Chair



Dear Commissioners and Stakeholders,

Health care continues to evolve by way of technological advancements, legislative and policy development and implementation, and the growth of interstate licensure compacts for health care professions. Now in its 25th year, the NLC continues to assist the nursing profession by streamlining licensure and facilitating nurse mobility. At the end of

fiscal year 2024, the NLC welcomed Connecticut as the 42nd jurisdiction to join the compact. Significant progress with advocacy initiatives was made in Alaska and Massachusetts.

Several initiatives from the NLC strategic plan kept NLC committees busy during the past year. The NLC Rules Committee developed model language which BONs may include in their alternative-to-discipline (ATD) program participation agreements. The NLC Compliance Committee revised the NLC self-assessment tool, which will roll out after a pilot phase. The Policy Committee continued to update policies and the Training and Education Committee revised and updated fact sheets. The Memorandum of Understanding (MOU) between the NLC Commission and NCSBN was comprehensively reviewed and significant updates were made to the agreement. Finally, there were many instances of engagement and sharing of best practices with other compact commissions.

The initiatives of the Executive Committee will continue and there will be additional tools created to assist BONs. We also look forward to the full implementation of the NLC in Pennsylvania, Guam, the U.S. Virgin Islands and Connecticut, as well as celebrating additional states enacting the compact.

NLC Legislative Update

This summary indicates the states that introduced or discussed NLC legislation in fiscal year 2024:

Connecticut

When Gov. Ned Lamont signed the NLC into law on May 30, 2024, Connecticut became the 42nd NLC jurisdiction. The NLC will become effective Oct. 1, 2025. The bill has a sunset provision. A workgroup was formed in the bill to study NLC implementation.

Hawaii

A bill passed both chambers but did not advance out of the conference committee. To address immediate workforce needs, the Hawaii Hospital Association championed Senate Bill 63 to expedite licenses for nurses from out of state.

New York

The NLC was included in Gov. Kathy Hochul's 2025 budget. State Affairs worked closely with the ANA-NY chapter, which treated the NLC as a priority this year. The New York State Nurses Association (the nurse union) was in opposition. In May the state held its first hearing on the NLC, and The Assembly Higher Education Committee voted to hold the bill for consideration.

Alaska

The NLC advanced further than in previous years but did not pass. The NLC effort gained new allies, especially in the senate. Alaska passed its first compacts this session – the physical therapy and audiology/speech language pathology compacts.

Massachusetts

The NLC was featured in a *Boston Globe* op-ed in March, which highlighted an NCSBN survey that showed 90% of the state's nurses support the NLC. The compact was included in a large economic development omnibus bill but the legislature failed to come to a consensus on the bill and the legislature adjourned.

Minnesota

The state senate heard an omnibus bill that contained many compacts, excluding the NLC. Two amendments proposing the state enact the NLC were brought, but they failed by one vote.

NLC Strategic Plan Update

The NLC strategic plan focuses on four strategic initiatives that center on strategic partnership development and collaboration, education of boards and stakeholders, promotion and engagement, and research and impact evaluation. The plan covers three fiscal years (FY23-25). Initiatives include collaboration, education, marketing and research.

Staff continued consensus-building with legislators in noncompact states, attending conference exhibitions to promote awareness of the compact, holding discussions with research partners regarding grants for NLC research, and planning to retain an investment advisor and financial auditor to advise utilization of the NLC fund balance, ensuring fiscal accountability and compliance with NLC statutory requirements.

The NLC held trainings at seven BONs, continued promotion of the commissioner handbook, and continued offering its annual governance training. The NLC continued its outreach growth by increasing public email subscribers by 66.8% over the previous year, collaborated with NCSBN marketing on a yearly project plan, provided legal opinions for NLC-related inquiries, continued to identify research topics for joint work and promoted Nursys® products at conference exhibitions. Staff worked diligently to disseminate information about the 60-day residency rule by creating a list of FAQs and incorporating information into monthly webinars.



Midyear and Annual Meeting Summary

The 2024 hybrid NLC Midyear Meeting was held in March in Atlanta, with all 41 commissioners in attendance, either virtually or in person. State and federal legislative updates were presented, and commissioners heard updates on committee projects such as the Rules Committee ATD program requirements, and supplemental guidance for BONs regarding the amended 60-day residency rule. The Compliance Committee began revisions on the self-assessment tool, and the Training and Education Committee produced a revised NLC definitions list. Committee chair Sherry Richardson (NLC Commissioner, Tennessee) presented the 25th Anniversary Committee and its purpose for planning celebrations throughout 2025. NLC Consultant Fred Knight, JD, presented two educational sessions on disqualifiers to a multistate license. NLC Chair Pamela Zickafoose introduced the new NLC commissioner handbook.

The NLC Annual Business Meeting was held in August in Chicago with 41 commissioners in attendance. Nominations were accepted for three positions on the NLC Executive Committee. The Rules Committee drafted model language that BONs may include in ATD program participation agreements. Three revised policies were approved, and Compliance Committee Chair Carol Moody (NLC Commissioner, South Carolina) reported that the revised self-assessment tool will have three components and the committee requested that several BONs pilot the program. The NLC 25th Anniversary Committee created the tagline “The NLC: 25 Years of Multistate Mobility for Greater Access to Care.” Awards were given to retiring NLC commissioners Joe Baker Jr. (NLC Commissioner, Florida) and Jay Douglas (NLC Commissioner, Virginia).



Hybrid Governance Training

The NLC presented its annual governance training for new commissioners prior to the 2024 Annual Meeting. The first speaker, Nahale Kalfas, JD, legal counsel to the National Center for Interstate Compacts at The Council of State Governments (CSG), explained the authorities of the NLC and the organizational structure of the NLC executive, standing, and ad hoc committees. During the second half of the training, speakers NLC Consultant Fred Knight and NLC Director Jim Puente presented case scenarios in a roundtable format.

2024 NLC Virtual Legal Conference Series

NLC presented a virtual eight-session series throughout June and July 2024 on various legal issues pertaining primarily to attorneys and investigators. Topics included the impact of the Dobbs decision on the NLC, an examination of the Uniform Licensure Requirements (ULRs), requirements and best practices related to ATD program participation, granting/denying an application for a multistate license, and order language used when disciplining a nurse with multistate privilege. The conference was approved for continuing legal and nursing education units.

The meeting topics included the best practice of processing the Duplicate Multistate Report, the Nursys API tool, denials for cause as a disqualifier to issuance of a multistate license, enhancements to Nursys NLC reports, clarification on having an RN and an LPN in the same state, and actions that NLC states take when they learn of a 60-day rule violation.

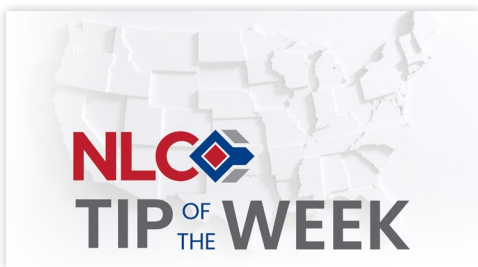

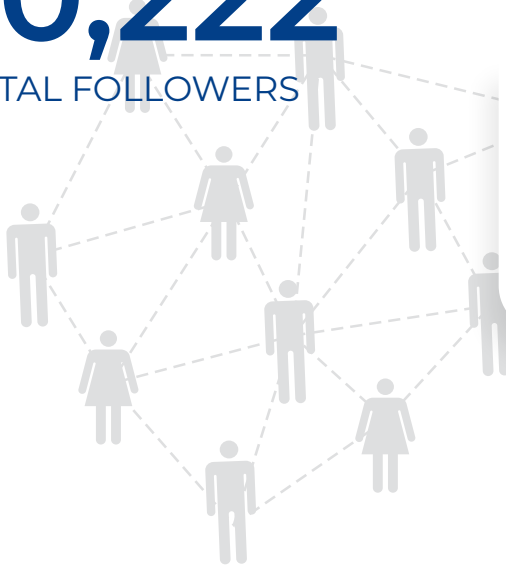

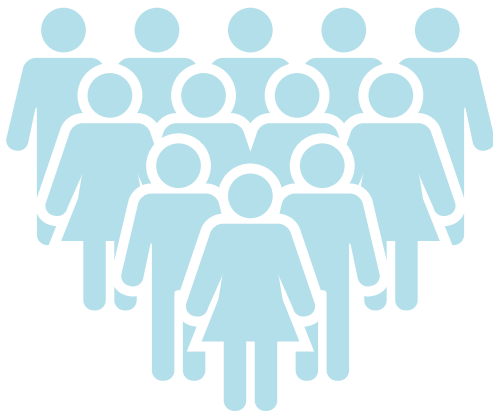

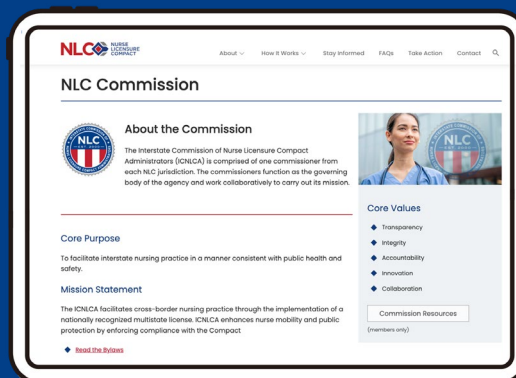

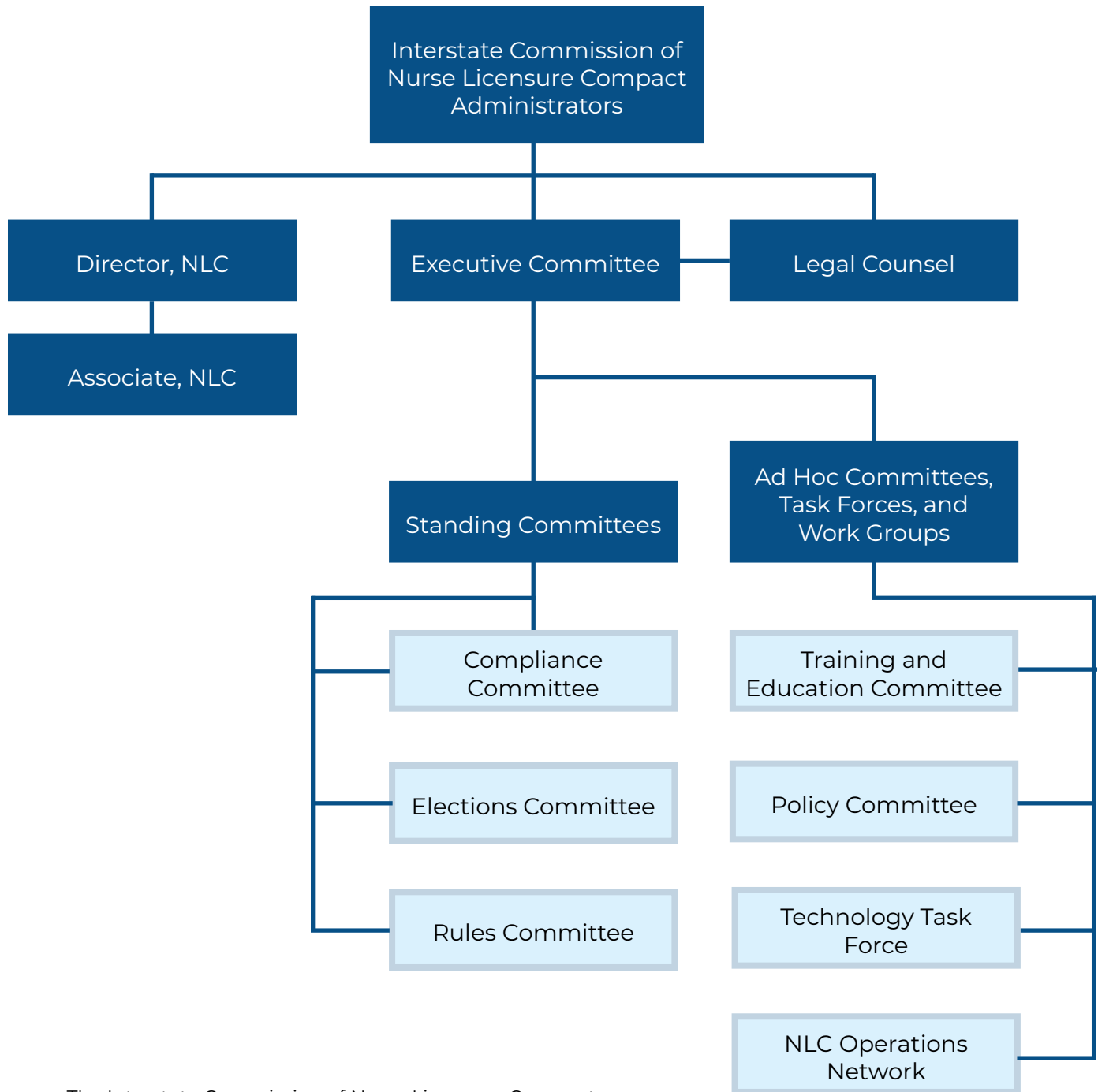
