When referring to Board of Nursing, the reference collectively includes Board Members, Executive Officer and Staff.

Jurisdiction: Refers to state, territory or district where a Board of Nursing is located. May also be used to refer generally to the Board of Nursing in a particular jurisdiction.


Board Staff: Staff of the board of nursing

**Executive Officer:** Person responsible for running the Board of Nursing. Includes any other terminology to refer to that authorized person (i.e. Executive Director)

Board Member: Member of the governing body of the Board of Nursing as outlined by statute

Practical nurse or PN: Licensed practical or vocational nurse (LPN/LVN)

















































## Q30. Can non-board members be appointed to serve on board member committees, task forces, etc.?



# Q31. Are committees comprised of board members and/or board staff utilized to complete assigned tasks for the Board of Nursing?





## Q38. Is the Board of Nursing budget cycle based on a fiscal year beginning January 1 or a fiscal year beginning on a date other than January 1?





### Q40. What percent of the budget is allocated for disciplinary matters?




