Unlocking Access to Nursing Care Across the Nation



The NLC is an interstate compact.

It authorizes a nurse with primary state of residence (PSOR) in a compact state and holding a multistate license, to practice (physically or via telehealth) in any compact state.



### Why Would a Nurse Need More than One License?

A licensee must have the authority to practice in the state where the recipient of nursing service is located at the time service is provided (unless federally exempted).

"As the organizations representing...state...licensing boards...that regulate the practice of medicine, pharmacy and nursing, ... (we) affirm that in a consumer protection model, health care practice occurs where the recipient of healthcare services is located."

- Residents of the 5 new states need to apply for a multistate license. Applicants will be evaluated to see if they meet the <u>requirements for a multistate license</u>.
- They do not automatically have a multistate license upon the implementation date.



### NLC is Passed in Kansas

Will be implemented 7/1/19

- Look for more information closer to the date.
- Nurses will not be able to practice in KS and KS residents will not be able to obtain a multistate license until the implementation is complete.



# **Anticipated Legislation**

## License Renewal

 Once a nurse is issued a multistate license, the nurse can stop renewing any license held in another compact state.



# Moving (Changing Primary State of Residence) Note: There is no grace period

- 1. When a nurse holding a multistate license moves from one compact state to another compact state, upon moving to the new primary state of residence, the nurse must apply for license by endorsement. The nurse should not delay in making application.
- 2. The nurse may practice in the new state of residence with the multistate license issued by the former state, until the multistate license is issued by the new state.
- 3. Once the new license is issued, the former state license is made inactive.




