Survey Terminology

The following terms are used throughout all surveys:

Board of Nursing: Jurisdiction's governmental agency responsible for the regulation of nursing practice. Includes any other terminology to refer to the regulatory authority (i.e., commission, examiners, registration, jurisdiction). When referring to Board of Nursing, the reference collectively includes Board Members, Executive Officer and Staff.

Jurisdiction: Refers to state, territory or district where a Board of Nursing is located. May also be used to refer generally to the board of nursing in a particular jurisdiction.

Board Staff: Staff of the Board of Nursing

Executive Officer: Person responsible for running the Board of Nursing. Includes any other terminology to refer to that authorized person (i.e., Executive Director)

Board Member: Member of the governing body of the Board of Nursing as outlined by statute

Practical nurse or PN: Licensed practical or vocational nurse (LPN/LVN)

Program Approval: The official recognition of nursing education programs which meet standards of approval established by Boards of Nursing. Some Boards of Nursing use the term accreditation instead of approval, but for the purposes of this document the term used will be approval.


Preceptor: An individual at or above the level of licensure who may serve as a teacher, mentor, role model, or supervisor in a clinical setting.

Articulation: seamless matriculation from the PN degree to the ADN or BSN degree or seamless matriculation from the ADN or diploma degree to the BSN degree or MSN degree.

Distance Education: Instruction offered by any means where the student and faculty are in separate physical locations.







Q3. Is the Board of Nursing responsible for the approval of nursing educational programs?







Q5. How many RN to BSN programs are in the jurisdiction?





Q6. How many exclusively online RN to BSN programs are in the jurisdiction?





Q7. If the Board of Nursing approves prelicensure nursing programs, would it approve one that offered no supervised clinical experiences for actual patients?



Q8. Is a regular review of education programs required for ongoing program approval?









Q13. What is the charge for the initial approval application?







Q16. Does the Board of Nursing use a specific first-time NCLEX pass rate for continuing program approval?





Q17. Does the Board of Nursing use trends of NCLEX pass rates for continuing program approval?





Q18. What standard does the Board of Nursing require for NCLEX pass rate?







Q20. If the jurisdiction's NCLEX pass rate standard is the first-time NCLEX pass rate of the program, what first-time NCLEX pass rate do you require?





Q21. What are the minimum educational qualifications for PN program administrator?







Q23. What is the mandated percentage of full-time faculty for PN education programs?





Q28. What is the student to faculty ratio for supervised acute-care clinical experience for PN education programs?







Q30. Does the Board of Nursing approve clinical facilities for PN programs?





Q42. Is the use of preceptors for providing supervision and/or education to RN students regulated by the Board of Nursing?





Q43. Does the Board of Nursing approve clinical facilities for RN programs?





Q44. What is the maximum amount of clinical hours that may be replaced by simulation hours?









Q47. Do you require an annual report from your prelicensure nursing programs?





Q48. When approving your prelicensure nursing programs, do you use the NCSBN Regulatory Guidelines?





Q49. Does the Board of Nursing approve out-of-jurisdiction distance education nursing programs?





Q50. Approximately how many complaints does the Board of Nursing receive each year related to in-jurisdiction-based distance education programs?





Q51. Approximately how many complaints does the Board of Nursing receive each year related to out-of-jurisdiction based distance education programs?


