### Historic Licensure Model for Nursing: License boundary = state line

- State-Based Licensure
  - Gibbons v. Ogden states have power under the US Constitution to regulate and license local matters
  - License issued and enforced by the state.
  - One license per state

- Modern Challenges
  - Jurisdiction
    - (Telemedicine)
    - Increasingly mobile society
    - Distance education
  - **Possible Solutions** 
    - National licensure
    - Endorsement
    - Reciprocity agreements
    - Mutual recognition



## What is an Interstate Compact?

- Roots in the United States Constitution
  - Article II Section 10: "No state shall, without the consent of congress...enter into any Agreement or Compact with another state, or with a foreign power,"
- "a formal binding contract, authorized by or enacted as legislation, between two or more states in their capacity of states"- The Evolving Law and Use of Interstate Compacts
- Purpose: remedying a particular problem of multistate concern





# Compact with Mutual Recognition Model of Licensure

**Driver License Compact** 

- I am issued a license in PA
- I can drive into Ohio
- I can get a speeding ticket in Ohio






### What is the Nurse Licensure Compact?

- Tool = Interstate Compact
  - Contract between the states
- Operation = Mutual Recognition
  - One state-based license
    - It allows a nurse to have one multistate license (in primary state of residency)
  - Nationally Recognized
    - This permits the nurse to practice in other member states (physically, electronically, and telephonically)
  - Locally Enforced
    - Subject to each state's practice laws

## Historical Perspective of the current NLC

- 1997: Endorsed mutual recognition model at Special Delegate Assembly; Approved NLC
- 1999: First state passes NLC legislation
- 2000-2010: 24 states enact NLC
- 2015: Montana is 25<sup>th</sup> state to enact NLC





# Key Components

#### PSOR

- Signed Declaration
- State Where Applicant Can Prove Legal Residence
  - Drivers license with home address
  - Voter registration card with home address
- One PSOR per person

#### Nurse Licensure Compact Administrators (NLCA)

- Governing body created by the compact
- One administrator from each party state
- Govern policy and procedures of the compact

#### Communication Tools

#### Participation in Nursys

- Coordinated licensure information system for party states to share licensure and disciplinary actions
- Current significant investigative information
  - Investigative information that indicates a nurse represents an immediate threat to public health and safety regardless of whether the nurse has been notified and had an opportunity to respond.
  - Post notice [alert] of investigation in Nursys and remove notice [alert] within 10 days of action



#### **Overall View of a NLC Investigation Process**

Licensee practicing in a remote state on PTP:

- Complaint allegation received by remote state, home state or both states
- Initial inquiry: Determine residency of respondent, establish the location of incident(s), & open the case if warranted
- Both home & remote states may mutually determine investigative lead
- Frequency of communication between states determined by agreement & level of risk

#### Actions

- A remote state may take adverse action affecting the multistate licensure privilege to practice within that party state.

  Home state action affects ability to practice in <u>all</u> party states.

# Who benefits? Nurses

- Ability to practice in multiple states with one license
- Reduces regulatory requirements by removing necessity for obtaining a license in each state
- Clarifies a nurse's authority to practice in multiple states via telehealth





# Who benefits? Nursing Boards

- Ability to share complaint and investigative information throughout the investigative course
- Shared responsibility for patient safety not governed by geographical boundaries
- Shared commitment to improving the collective ability to protect patients







# **Reasons for Change**

- Trend toward CBCs for licensed health care professionals
- Uniformity
  - ULRs
- Need for facilitating interstate nursing practice continues to grow
  - Telehealth boom, distance education, etc.
- Current NLC states wanted to ensure long-term growth and viability of the NLC
  - GOAL = 50 state compact



### NCSBN's Response to Change

#### 2013-2014:

-NCSBN members convene a series of meetings to consider best possible licensure model -Decision made to continue using an interstate compact and revise the existing NLC

#### 2014-2015:

-NLC is redrafted as a new compact

#### May 4, 2015:

-NCSBN members overwhelmingly approve enhanced NLC and APRN Compact at a Special Delegate Assembly

#### May 2015:

-NCSBN Board of Directors commits staff and financial resources to advocate for state

adoption of enhanced NLC



## What are the "enhancements"?

- Uniform licensure requirements
- Grandfathering provision
- Authority to obtain and submit criminal background checks (CBCs)
- Prompt reporting to Nursys® of participation in alternative to discipline programs
- Establishes Interstate Commission
- Provides for rulemaking by the Commission
- Improves dispute resolution and termination if necessary



## Effective Date

- A state must pass the enhanced NLC legislation to join the compact
  - Does not become effective until the earlier of enactment by 26 states or Dec. 31, 2018
- Multistate licenses issued under the current NLC will still be recognized by party states in the enhanced NLC for six months after the eNLC effective date
