Dr. Carmen Catizone's profound commitment to public safety was a hallmark of his long and impactful career as executive director of the National Association of Boards of Pharmacy or NABP. He is known as a collaborator extraordinaire for his ability to work within his own profession as well as other healthcare disciplines.

He has collaborated with his peers in nursing, medicine, psychology, physical therapy, occupational therapy, and social work to collectively identify regulatory research gaps. This resulted in the publication of an analysis of the occupational licensure literature that highlighted a number of strengths and weaknesses that needed to be addressed.

His work along with the CEOs of Federation of State Medical Boards and NCSBN led to the development of the Tri-Regulator Collaborative and the subsequent biennial Tri-Regulator Conference, an idea that has been mirrored in a number of states across the nation. Carmen has always been keenly aware of emergent and evolving issues, explored them with vigor, and formulated proposals to the pharmacy community and other disciplines.

Constantly looking for opportunities to amplify impact through bringing disciplines together to speak in harmony, he has been a leader and innovator throughout his entire career. In the late 1990s, he explored tele-pharmacy, and more recently the development, implementation, and widescale adoption of the prescription monitoring program Data InterConnect.

This system provides a service to all prescribers and is essential in the fight against the opioid crisis. His work on the dangers of internet pharmacies has led to changes at the national and global levels, making healthcare safer for both patients and prescribers. As a prolific speaker around the globe, he has provided expert testimony to the DEA, individual states, and Congress.

Carmen is a regular contributor to both FDA and DEA training and policy sessions. He is also the author of multiple book chapters and articles and makes regular media appearances. He has fearlessly asked the

difficult questions that must be tackled if public safety is to remain at the forefront of care both in the U.S. and around the world. Carmen dedicated his professional life not only to NABP but also to the wider community of health practitioners and for-patient-centered teams.

Significantly, he has been an enduring ally to NCSBN for many decades and across a range of issues. It is for that reason that Carmen joins an exclusive group of honorees who have been given the Founders Award.

And of course, David. Since NCSBN's founding in June of 1978, the organization has grown under the steady leadership of the board of directors, staff, and watchful eyes of its dedicated members. What was once the dream of a taskforce of devoted volunteers is now a gold standard for regulatory and competence assessment organizations.

While I was at NABP with every major issue that we undertook, one of the first questions we always ask is, "What are the nurses doing?"
