Known as a critical thinker unafraid to ask the hard questions, Kim Glazier has been an innovative leader throughout her tenure at the Oklahoma Board of Nursing, at the national level as the chair of the Nurse Licensure Compact commission, and through her membership in extensive committees and task forces.

During her 22 years of service as the executive director of the Oklahoma board, her wealth of knowledge and leadership has produced significant changes. This leadership propelled the agency to become the first licensing board to process online licensing of all applicants, verification of licensure for public use, and electronic access to public files. Using evidence-based practices, she implemented the state statutory Peer Assistance Program for nurses with substance use disorders.

She organized the evaluation of the state's newly-passed legislation, requiring the Board of Nursing to identify the criminal offenses that would render a candidate ineligible for nursing licensure. The Oklahoma board was the first licensure board to complete this crucial project, and became the example for other licensure boards to follow.

She mentored several new executive officers and assisted them as they learned their role with NCSBN at the state level. She ensures her staff members have the appropriate knowledge and expertise to effectively perform their duties. Her staff is also actively involved in a state committee that works to decrease prescription drug abuse.

Kim's exemplary work and service was recognized in 2014 by The Journal Record as one of 50 women making a difference in the state. Also in 2014, she was named one of the great 100 nurses in Oklahoma. Steadfastly dedicated to regulatory excellence, she has worked diligently to advance the mission and initiatives of NCSBN.

This includes work on the NCSBN Model Act/Rules related to the campaign for APRN Consensus within two years of the delegate assembly adoption. Kim worked to employ the education revisions made to the NCSBN Model Act, including use of simulation for a percentage of clinical hours and acceptance of National Accreditation Reports in lieu of state survey visits.

She assisted her board in identifying statute and rule changes necessary to implement NCSBN's Regulatory Decision Pathway in their discipline decisions. For her sustained and significant contributions to the highest commitment and dedication to the mission and vision of NCSBN, Kim is honored with the R.

Louise McManus Award this year.

I'm forever indebted to our board staff for their endless positive energy, high-quality work, and unyielding support as we've implemented various projects that continue on in their daily work today.
